END USER LICENSE AGREEMENT WITH YAHSHUA OUTSOURCING WORLWIDE, INC.

ACCEPTANCE OF TERMS.

You should carefully read the following terms and conditions before using the YAHSHUA Software. This YAHSHUA Outsourcing Worldwide, Inc. End User License Agreement is a legal agreement (hereinafter referred to as this "EULA") between you (either an individual, company, or any other entity) and YAHSHUA Outsourcing Worldwide, Inc. for this YAHSHUA Software product which will be referred in this agreement as the "SOFTWARE". GOVERNING LAW.

This EULA shall be governed by the laws of the Republic of the Philippines.

SOFTWARE PRODUCT LICENSE.

The Software product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE is licensed, NOT SOLD.

USE AND REGISTRATION.

This is not a free SOFTWARE. You agree to register this SOFTWARE with YAHSHUA Outsourcing Worldwide Inc. (YAHSHUA).

1. GRANT OF LICENSE. This EULA grants you the following rights:

YAHSHUA grants you as an individual, a personal, limited, non-exclusive license to use the SOFTWARE product.

For Mobile Application: You may install a limited copy of the SOFTWARE on any computer, mobile device or as agreed by YAHSHUA. A license for the SOFTWARE product may be shared or used concurrently on different devices.

For Web Application: YAHSHUA grants the user or company a limited, non-exclusive rights to use the SOFTWARE. The SOFTWARE is bounded on a per company basis and not per computer installation. The number of users may also be restricted depending on the written agreement between YAHSHUA and user.

Collection Of Data

Further, we will be unable to provide you with any updates on the upgrades of YAHSHUA systems, and you may be unable to participate in our events, promotions, or other activities.

The law also grants you the right to suspend, withdraw, or order the blocking, removal, or elimination of your Personal Information in our processing systems upon discovery and substantial proof that your Personal Information is no longer necessary for the purposes it was collected, and for such other cases provided in the Data Privacy Act of 2012.

Use Of Data

- b) Help us improve our quality of products and services;
- c) Create new products and services;
- d) Enhance your customer experience and determine tailored content to meet your preferences and needs;
- e) Communicate relevant services and/or advisories to you;
- f) Abide by any safety, security, public service or legal requirements and processes;
- g) Process information for statistical, analytical, and research purposes. When disposing of your Personal Information, we take reasonable measures to ensure that it is done properly and is not accessible to the public.

We are not responsible for information, content, application, product, or service that we do not provide. But because we care for you and protect you, we take measures to fight spam, fraud, or any

unauthorized messages that traverse our network.

We shall cooperate with law enforcement agencies to curtail criminality and prevent criminals from wreaking havoc over the internet, which shall include the blocking of certain sites or prevention of access to certain individuals, all in accordance to the stipulations of the law and with respect to legal due process.

4. UPGRADES OR MODIFICATIONS.
